3. AIMS & OBJECTS :

- g) To organize and manage a self- supporting canteen and a bar in the premises of the club for members.
- h) Arrange regular cultural and social programs for members.
- i) To organize and conduct tours and visits to national projects, industries and other places of interests "in the country and abroad", if possible in cooperation with other agencies for the benefit of members and journalists in general.
- j) To do all such acts as are incident or conducive to the realization and furtherance of the objective of the Club.

The Club may raise funds through donations and other means to meet the expenditure for the above actives as well as for buying furniture, for library equipment, for canteen and other activities of the Club fund raising of funds the question of coordination with any organization do not arise as the Club is an Autonomous body.

RULES AND REGULATIONS

1. The Press Club, AMARAAVATHI shall admit the following categories of members.

1) Regular members:

- a) All individuals whose main avocation is the profession of journalism "as defined in the working journalists Act and working in AMARAAVATHI Capital Region" are eligible for membership of the Club "Members of reporting and editorial staff of electronic media, both private and government whose principal avocation is journalism will also be eligible to become regular members. The member number should not exceed 1500 or the ceiling may go as it is not possible to give membership to more than 500 persons in one go. The restrictions on the number of members to propose and second an application can be increased by an Executive decision. And the members from both Private and Government media, whose principal avocation is journalism will also be eligible to become regular membership. To strengthen it further, to convert the membership of all government employees, working or retired, drawing salary or pension who are/were (NOT) directly connected to the profession of journalism as Associate Members.
- b) Application for enrollment as a regular member will, in the first instance must be proposed by a regular member of the Club having not less than three years standing and be seconded by not less than two regular members of minimum two years of standing in the Club. No member of the Club can either second or propose more than one regular and one associate member in a year.
- c) An application for membership shall be in a prescribed form obtained from the office of the Club. All applications should be duly filled.
- d) After scrutiny the Executive Committee may admit or reject or keep it in abeyance any application without assigning/any reason whatsoever. The Executive Committee may also call for any information about the applicant to satisfy itself. Committee may request any applicant to appear before the Committee for an interview. The Executive Committee may appoint a sub-committee consisting of senior members to scrutinize the applications.

The applicant shall produce three the appointment letter and salary certificate copies, to the satisfaction of the Committee.

- e) The proposer and the seconders shall not be defaulters either in the bar or in subscription or any other such dues to the Club at the time of proposing or seconding.
- f) For any reasons if any regular members leave the profession, and join some profession other than that of Media, then the membership of such member will be reviewed by the E.C. and a decision will be taken after hearing the opinion of the member concerned.

I. Associate member:

The Executive of the Club may in its discretion extend associate membership to the following. The membership should not exceed 30% of number of the Regular members.

- a) Public Relations Officers of public or private concerns.
- b) Information Officers of state and central governments.
- c) Managers and executives of newspaper establishments and advertising agencies.
- d) Information and cultural Officers of Foreign Embassies or Consulates.
- e) Teachers of journalism.
- f) Executives of organization or institutions, Which in the opinion of the Executives of the club are likely to promote the objectives of the club.

III. Outstation members:

As and when a member is transferred to places outside AMARAAVATHI he or she will automatically become outstation member. The status will be changed immediately after the transfer, if the person concerned wishes to continue as a member of the club.

IV. Corporate Member:

Membership will be given to Corporations.

- a) The Company should be listed in the NSE or BSE to be eligible for getting Corporate Membership.
- b) PSUs under State and Central Governments are also eligible for Corporate Membership.
- c) Any Company associated with the Club for furtherance of its welfare activities and infrastructure development can also be considered for Corporate membership.
- d) The Corporate, on acceptance, can nominate any one of its associates who shall have the privileges of Associate Members.
- e) Application for enrolment shall be made in the prescribed form supported by two Regular members along with the admission fee of Rs. 2,00,000 (Rupees Two Lakhs only).

2) IDENTITY CARD:

All categories of members shall possess identity cards prepared and printed with the member's photograph affixed on it. The executive committee shall charge such cards.

Any change in category of membership, say from regular to life membership, the member concerned shall pay the cost to new card.

for the annual renewal of the card, the member shall pay towards the new card.

The member shall produce the identity card when demanded under any circumstances either by the office bearers/Club staff or any other authorized person by the President.

4) **Honorary member:** Honorary membership can be conferred on eminent persons from various walks of life with their consent.

There will be no fees for this category..

The family of the member of any category can make use of the facility of the Club. Family is defined as the spouse and two children of the member.

4a. Guest rule: Members are allowed to bring a maximum of ten guests per month. However, no member can bring the same guests for more than three consecutive days. Women and Children are exempted from this rule. No particular guest can visit more than four times in a month.

5) Any member who defaults in payment of subscription for a period exceeding three months shall cease to be a member. He may be reinstated to the membership if he pays all the dues within the next one month.

6) **Removal of member:** The executive of the Club shall be competent to remove any member from the rolls if in the opinion of the Executive, the member has acted against the interests of welfare or reputation of the journalists or the Club. Such a member holds the right of appeal against the action of the Executive to the General Body of Club whose decision shall be final.

7) Any member may resign his membership but the subscription once paid shall not be refunded.

New membership category: As per General Body decision taken earlier, membership will be given not before 2 years and any time after that depending on sole decision of the Executive Committee. This will be based on Availability & Facility.

New membership will be accorded only on Annual Temporary Member for Regular/Associate/ Corporate Members.

After 2 years, the Executive Committee will review and accord regular the membership on its sole decision and without notice & information to the member.

8) **Patrons:** The Club may have a patron in chief and patrons not exceeding six.

9) **Club management:** It is proposed to increase one post each of Joint Secretary and Vice President and add 4 more executive committee members of the present set up. Also change the designation of Secretary to General Secretary. Finally we can have one President, two Vice- Presidents, one General Secretary, two Joint Secretaries, one Treasurer and 10 committee members. Finally it will be 17- members Managing Committee.

One post of Vice- president and two Executive Members shall be reserved for Women members.

In the Preamble it is already amended that the Club is hereafter called autonomous body, hence co-option from any organization does not arise.

As we are reserving three posts exclusively for women members, co-option of women members from any organization is also not required.

10) Duties of the Executive

President: The President shall convene and preside over the Executive and General body meetings and will cast his\her vote in case of a tie on any issue in the Executive.

Vice President: He/ She shall assist the President in the conduct of his duties and preside over meetings in the absence of the President.

General Secretary: The General Secretary is the Executive Head of the Club and is in-charge of the day to day functioning of the Club and takes decisions as the Executive head, later they can be ratified in the Executive Committee, if necessary. He/ She shall be in close liaison with the Office Bearers and Executive Members.

Joint Secretary: He/ She shall assist the General Secretary in running the Club, and shall act in the absence of General Secretary. He/ She shall maintain the minutes of the meeting and will look after the Club activities.

Treasurer: He/ She shall be in-charge of the funds of the Club, responsible for the depositing the Club funds in a nationalized bank(s) as approved by the Executive, maintain accounts, petty cash and submit accounts every month to the Executive. He/ She shall jointly operate the Bank accounts with Secretary.

11) Executive committee of the Club is the governing body of the Press Club. It shall meet atleast once a month and take decisions on the basis of majority.

The Executive can constitute sub committees consisting of not more than five members for discharging specific functions entrusted to it. The President or General Secretary shall be an ex-officio member of the subcommittee.

The Executive committee at its first meeting shall appoint one internal auditor who is not a member of the Executive committee.

The quorum for the executive meetings shall be six. Notices for the Executive shall be ordinary three days. Emergency meetings can be held with 24 hour notice.

The Executive shall be convened if one third of the membership of the executive requests in writing giving reasons for holding such a meeting at such meetings matters specified by the members shall be discussed.

The Executives shall have the power to appoint salaried employees of the Club.

The Executive Committee shall frame additional working rules for regulating the day to day functioning of the club and holding elections as per the Constitution.

The Executive Committee shall have the powers to affiliate this club with similar other Press Club in India and facilities of this Club to the members of others Press Clubs strictly on the basis of reciprocity. Any correspondence in this direction and any decisions taken by the Executives shall be announced on the notice board of the Club and brought to the notice of the earliest General Body meeting.

12) GENERAL BODY MEETING

- i. The Annual General meeting of the club shall be held in the month of **JANUARY - EVERY YEAR** and not later than the end of June of the following year. The official year of the Club shall be January 1 to December 31.
- ii. Extra- ordinary meeting of the General Body may be called by President or majority of the Executive Committee whenever necessary. An extraordinary meeting of the General Body shall be called by the President upon a written request by not less than one- tenth of the total effective Regular members.

Such a request must be handed over to the President or General Secretary 30 days before the proposed date of meeting and in such a meeting no subject other than that mentioned in the requisition shall be discussed.
- iii. For any General Body meeting 15 days clear notice shall be given. The notice shall be posted or delivered to members; it shall specify the agenda, venue and time of the meeting. For the Annual General meetings copies of audited balance sheet and report of the Secretary shall accompany the notices of the meetings.
- iv. The quorum for any General meeting shall be not less than one- tenth of the effective Regular membership. Only regular members on the date of the meeting shall have the right to participate and vote. If other categories members are invited to any meeting, they may participate in the deliberation without the right to vote. If there is no quorum even one hour after the time specified in the notice the meeting shall be adjourned. At any such adjourned meeting, the business of the original meeting shall be disposed of whether or not there is a quorum.
- v. The decisions of the General meeting shall be by a majority vote either by show of hand or by any other procedure decided at the meeting.
- vi. The Annual General Meeting shall elect the executive once in **TWO YEARS**. It shall approve the annual accounts and Secretary's report. The general body shall be the supreme body of the Club.

13) ELECTION:

- i. Nominations should be on the prescribed form proposed by one Regular member and seconded by not less than three Regular members and acceptance of the candidate. No members other than effective Regular member shall, propose nor second a nomination.
- ii. Effective regular member whose membership is not due only shall be eligible for election.
- iii. Only effective regular members on the rolls on the date of the election shall have the right to vote.
- iv. The Election to Executive shall be held in accordance with the election schedule to be framed by the Executive and notified in advance.
- v. The Executive Committee will appoint a returning officer who shall conduct the election as per the schedule prescribed by the Executive Committee.
- vi. Nominations shall be filed seven days before the date of election. Any nominations may be withdrawn in writing by the candidate.
- vii. Any given Eligible Member cannot contest for two terms for the post of President and General Secretary.

14) FUNDS:

- i) Admission fees, membership, subscriptions, donations and other collections shall form the general fund of the Club with two separate heads: regular accounts showing admission fees and membership, subscriptions, donations and other collections as special account.
- ii) Regular continuing expenses such as maintenance of the Club premises, employees, electricity charges of the Club and other incidentals like teas and coffees at formal meetings with invites shall be charged to the regular account.
- iii) Overhead expensed such as consolidation or expansion of the library, furniture, equipment for the kitchenette, shall be charged to the special account.
- iv) The running of the canteen shall be made self supporting as far as possible self supporting.
- v) For example, visit to the projects, Industries etc., may be arranged in such a manner that the Club shall not shoulder any financial burden.
- vi) Since the general fund of the club shall be spend for the promotion of the objectives of the Club shortage or deficits in some activities may be met by allocations from the regular account or special account. There may even be transfer of funds from the regular to special or vice versa. Any such allocations or transfers shall be brought to the notice of the executive at its earliest meeting.
- vii) The Club's general fund shall be deposited in a nationalized bank approved by the Executive of the Club, and the account shall be operated on a joint signature of the Treasurer and Secretary.

15) AUDIT:

- i. The accounts of the Club shall be securitized quarterly by internal auditor who shall be nominated by the Executive and report should be placed before the Executive committee at the earliest.
- ii. The accounts of the Club shall be audited by a chartered accountant appointed by the Executive.

16) AMENDMENTS

Amendments to the Preamble or the rules and regulations of the Club shall be passed only at a General Meeting called for that purpose and with a simple majority.

17) DISSOLUTION

- i. The Club may be dissolved by a specific resolution adopted by not less than three fourths of membership of the Club at a special general meeting of the Club convened for that purpose.
- ii. Provided that one month's clear notice is given separately to all members of the club for the meeting and along with the notice two resolutions, one regarding the dissolution of the Club and other regarding the disbursement of the funds on dissolution are also circulated.


